Re: 2017-18 One-Time Graduation Initiative 2025 Allocations

To support key focal areas of Graduation Initiative 2025, \$8.9M in one-time resources will be allocated for strategic priorities. These allocations result from the redirection of existing resources toward these priorities in 2017-18:

Each campus will receive **\$140,000** to support work in FY2017-18 on restructuring academic preparation in English and mathematics. Funds may support summer stipends for faculty engaged in innovation and instructional improvement, academic year buyouts for curricular redesign, faculty development related to instruction in English and mathematics, or other curriculum and instruction-related activities.

An additional **\$120,000** will be allocated to each campus to either: 1) invest in technology to further support data-driven decision making or 2) expand financial support or financial literacy programs. Campuses may choose one of the two categories for 2017-18.

Select campuses with low success outcomes in lower-division math courses will also receive **\$300,000** for course redesign over a two-year period. Funds may support summer stipends for departments and faculty engaged in instructional innovation, academic year buyouts for curricular redesign, faculty development related to instruction in mathematics, or other curriculum and instruction-related activities to improve course outcomes.

In addition, the Office of the Chancellor will utilize related funds along with external support to launch the CSU Center for the Advancement of Instruction in Quantitative Reasoning, coordinate systemwide faculty development opportunities related to quantitative reasoning and seek external matches from funding agencies.
