The Trustees and the Service Provider hereby agree to amend Master Enabling Agreement No. 30781, hereinafter referred to as Agreement as follows:

1. The Trustees elect to exercise the option of extending the term of the Agreement for an additional one (1) year period, subject to the same terms and conditions, beginning July 1, 2008, through June 30, 2009.
2. The Service Provider shall report to the Chief of Construction Management, California State University, Office of the Chancellor.
3. All provisions of this agreement, as it may have been amended, shall remain in full force and effect unless expressly changed by this Amendment.
