## **Admissions**

## Fall 2025 Admission - Extra time to apply!

Several CSU campuses continue to accept transfer applications. Visit our <u>application</u> <u>dates & deadlines page</u> and use the "Is Your Campus Still Accepting Applications?" feature to view open campus programs and their deadlines.

#### **Transfer Academic History Update**

As part of the application process, the CSU requests transfer applicants update their academic history information in <u>Cal State Apply</u> during the month of January. Fall 2025 transfer applicants can now make academic history updates in Cal State Apply through **Friday, January 31, 2025**. Applicants received an email with instructions and access to the <u>2025-2026 Academic History Update Guide</u> and will receive additional reminders next week.

The <u>2025-2026 Academic History Update Guide</u> provides clarification of what specific updates, additions and deletions can be made in the academic history section of Cal State apply during this period (page 4).

#### **Educational Opportunity Program (EOP) Deadlines**

Students who expressed interest and the intention to apply to the <u>Educational</u> <u>Opportunity Program (EOP)</u> in Cal State Apply should check individual campus EOP application and document deadlines on the <u>EOP Admission by Term website</u>. The majority of campuses have a **January 15, 2025** application deadline. Document deadlines include letter of recommendations.

If an applicant requests a letter of recommendation for the Educational Opportunity Program (EOP), Cal State Apply will automatically select a default deadline date two weeks from the date the applicant submits the request (e.g., if the recommendation request is submitted on January 1, the EOP deadline date automatically selects January 15). The default date cannot be changed. However, if the default deadline date passes, a recommender will still be able to submit a recommendation. All recommendations must be submitted by the documents deadline of January 31, 2025, unless noted otherwise on the EOP Admission by Term and Deadlines page.

## **Financial Aid**

Free Application for Federal Student Aid and California Dream Act Application
The Free Application for Federal Student Aid (FAFSA) form and California Dream Act
Application (CADAA) are open.

The current state deadline to file these applications is **March 3, 2025**, however, the CSU encourages students to submit earlier.

#### Mixed-Status Families

Mixed status families, students with a spouse or parent(s) that lack a Social Security number, are feeling uncertain and vulnerable during this time.

Mixed status family students that are hesitant to fill out the FAFSA, at this time, can complete the California Dream Act Application (CADAA). This will ensure they are able to be evaluated for state aid. If they wish to fill out the Free Application for Federal Student Aid (FAFSA) later, they can do so.


#### Training Opportunities

When a student submits their first application to any campus, regardless of the priority deadline, they will not be able to make any changes to any subsequent application. If students need to report any corrections or updates, please have them <u>contact the universities</u> they applied to directly.
