

Fall 2025 Priority Application Filing Period Update

This year, the priority application filing period for the fall 2025 term is **October 1, 2024** to **December 2, 2024**.

The Cal State Apply application for fall 2025 will be available on October 1, 2024 at 6 a.m. PST. Students are encouraged to wait until that time for the new application link.

Update on Mathematics (Area C) Requirement

Earlier this year, the University of California and their faculty Workgroup on Mathematics (Area C) Preparation issued <u>a report</u> focusing on the necessary and appropriate mathematical coursework to prepare students for success at UC. The CSU Math Council passed a resolution in support of these changes to math categories and math validation rules. As a result, the CSU will align its policy with the changes adopted by the UC. More information on these changes will be noted in our upcoming CSU Admission Handbook.

Transfer Success Pathway: Dual Admission to the CSU

CSU Financial Aid Updates

The U.S. Department of Education recently announced that the 2025-26 <u>Free Application for Federal Student Aid</u> (FAFSA) form will be released for testing to a limited set of students and institutions on **October 1, 2024**. The form will be available to all by **December 1, 2024**.

The <u>California Dream Act Application (CADAA)</u> is set to open on October 1 as of now. We will keep counselors informed with any updates regarding the launch date.
