



## **California Community College Guidance Initiative (CCGI)**

- In 2021, the enactment of AB 132 and Education Code 60900.5 made CaliforniaColleges.edu tools and services free for all LEAs that serve 6-12th grade public school students in California.
- CCGI has partnerships and integrations with all of California's public financial aid and higher education systems.
- For many years, the CSU has promoted the tools of CaliforniaColleges.edu and encouraged LEAs to partner with CCGI so that students can track their progress towards CSU eligibility
- Per California Education Code 60900(f)(3), by **January 2026**, high schools will need to enter into data sharing agreements with CCGI in order to provide transcript-informed account to students
- Transcript-informed accounts allow:
  - Students to view their progress toward CSU Eligibility requirements 0
  - Students to import their high school coursework directly into Cal State Apply 0
  - Educators to track students' progress towards eligibility and application submission statuses 0







# **Transfer Success Pathway Program**

The Transfer Success Pathway (TSP) program is a transfer program that allows students to enter into an agreement with a CSU campus that guarantees admission for a future term.

- Eligible Participants: First-time freshman entering a community college
  - Not CSU eligible *or*
  - Not able to attend due to personal or financial reasons
- Agreement with one CSU campus required
- Sign agreement in first fall term at CCC, after HS graduation

Agreement cycle is August 1 - September 30. Students can sign an agreement via the Transfer






