<p>9:00 – 10:30 am</p>	<p>Workplace Violence Prevention Panel</p> <p>Description: This session evaluates how the CSU addressed the requirements and will describe the next steps prompted by California Senate Bill (SB) 553. In late 2023, SB 553 established new occupational safety requirements that commenced in July 2024. Employers needed to implement workplace violence prevention plans (WVPP), and the CSU developed training, identified responsible persons, and established hazard assessment, hazard correction, incident review, program evaluation, and reporting protocols.</p> <p>Though many of the regulatory requirements are common for occupational safety programs, the association of WV incidents with law enforcement and the need for human resources support to ensure threatening behaviors are immediately addressed made this an unusual occupational safety program. Campuses and Systemwide partners took immediate action to ensure the WVPP were in place by July and meanwhile aligned the various stakeholders involved in the challenging requirements for the goal of providing a safe work environment.
