ASCSU Chair's Report

Plenary September 19, 2024

We have incredible opportunities before us in the CSU, and given that it is an election year, the stakes could not be higher for education in the United States and for the CSU. We are seeing attacks on higher education across the nation, systematic dismantling of academic freedom, banning of books, banning DEI, and a disruption of the establishments of an educated society. These constitute a loss of rights for which our country's veterans sacrificed so that we might sit here in this venue today. Our students face challenges we never experienced in our lifetimes, fear of non-acceptance into our nation, food and housing insecurity, looming financial obligations, and a lens on the world formed by living through a pandemic in the early years of their lives.

It is now more than ever that we need to strengthen shared governance and demonstrate the relevance of faculty in the co-governance of our institutions. My vision is to enact change in the ASCSU that will elevate its presence and role in Shared Governance.

Below are priorities and activities since I assumed office:

Advocate and reinforce the rights of faculty in Shared Governance

Letter to and response from the Maritime Interim President that affirmed the rights of faculty voice in the proposed integration of Maritime and SLO

Transition the ASCSU's work into being more action-oriented

Communication specialist appointments – assist with documentation and promotion of ASCSU work

Improve transparency and internal functioning of the ASCSU operations

Technology updates - DropBox to SharePoint, ASCSU Office 365 account
Communications updates - Appointment letter process, Systemwide Committee
Organizers notification and meeting request messaging, Travel letters
Transparency - For the first time, ASCSU senators can see agendas, minutes, and supporting documents for every committee, including the archives

Foster Relationships - Show up, be engaged, have hard conversations if needed, and listen

CSSA - Our students are central to the work we do in the CSU. I've been in attendance and reported to each CSSA meeting and was honored to serve on an interview panel at CSUnity and made connections with student leaders across the CSU

Alumni Council - Interviewed as a panelist at August council meeting CFA - Report at Fall Kick-Off

Meetings with Board of Trustees Chair Clarke and Vice Chair Arambula re: Board interactions with ASCSU, role of non-board members (seating and speaking rights), addressing sentiment that Shared Governance is Shared Death Juneteenth

Year of Engagement - June ExCom meeting with Deloitte

ASCSU-CO Leadership Summit in August - This year, the summit was held in person with about 20 people, including ASCSU Executive Committee, the Chairs of Standing Committees, and select administrators from the CO. Conversations centered on three sessions: 1) Identifying major issues we face in the upcoming year(s), 2) examples of successful partnerships and collaborations/best forms of participation and collaboration / communication practices important for successful collaboration, and 3) setting expectations - what roles do we have in solving identified issues / envisioning our work together on solutions

1:1 meetings with CO administrators, faculty trustee, students, and others

Foster and facilitate an inclusive, diverse, and equity-minded ASCSU

Committee and specialist appointments

Conversations with Board of Trustees, Chair Clarke (see above)

Nursing bills - opposition letters and veto requests
