As chair of the CSU Program for Education and Research in Biotechnology (CSUPERB) Presidents' Commission, I write to announce the appointment of Dr. Ikhide Imumorin as the Executive Director of CSUPERB, effective June 1, 2021.

Dr. Imumorin is Professor of Biological Sciences, and Director of Research and International Linkages in the Office of the President at First Technical University, Ibadan, Nigeria, adjunct professor in the School of Biological Sciences at Georgia Institute of Technology, Atlanta and was recently Program Leader for International Animal Agriculture in the College of Agriculture and Life Sciences at Cornell University, Ithaca, NY. He has total of 30 years of work experience, 20 years since earning his Ph.D. in Animal Genetics and Genomics from Texas A&M University, College Station in 2000. He holds an M.S. in Animal Science from Federal University of Technology, Akure, Nigeria and a B.S. in Agriculture (Animal Science) from the Federal University of Technology, Owerri, Nigeria.

His experience spans teaching, research and service as a professor, researcher, scientific collaborator, invited speaker, consultant, advisor, biotech entrepreneur, and mentor, and is involved in extensive international engagements. As a faculty member, he has mentored more than 60 undergraduate and graduate students, postdoctoral associates and research scholars from the United States, Africa, Latin America, and Southeast Asia. With academic output of one book, a book chapter,70 journal papers and over 100 abstracts and conference presentations, Dr. Imumorin's program has received grant support from the National Institutes of Health, National Science Foundation, U.S. Department for Agriculture, U.S. Agency for International Development, foreign governments, and from private industry and foundations. We are thrilled that we have been successful in recruiting Dr. Imumorin to lead CSUPERB and are confident that his skills and experience will continue to advance this critical initiative.

I would like to thank CSU Chico President Gayle Hutchinson, who served as chair of the search committee, as well as members: Dr. Paula Fischhaber (Deputy Chair, CSUPERB Strategic Planning Council, CSU Northridge), Dr. Stanley Maloy (Associate.
